President's Message

Dear Colleagues,

I am very sad to write my last President's address several months shy of the end of my term. As I mentioned in my email, I have resigned from the Board because my schedule at my new job at Kaiser does not allow me the flexibility to leave in the middle of the day for the meetings. Several months ago, I made the decision to leave my contracting position with the Department of Corrections and Rehabilitation

Description of the Duties of the Secretary

CCPA Board of Directors

The role of the Secretary is primarily to take minutes during the Board meetings. Familiarity with a word processing program is very helpful, as are basic skills in electronic communications (for example, email, posting documents to the online listserve, etc). The minutes are maintained electronically.

This position does require attending Board meetings in person, as well as maintaining membership in CPA. Otherwise this position is very flexible as it allows participation on additional committees as desired, but can be structured to require minimal time outside the Board meetings. It is a great way to contribute to the association, and to work with amazing colleagues on the Board of Directors.

Here is the official description of this position in the Bylaws:

The Secretary shall keep minutes of all meetings of CCPA and of the Board of Directors, which shall be an accurate and official record of all transactions of CCPA. The Secretary shall be custodian of all CCPA records, except those of the Ethics Committee. The secretary shall assume additional duties as may be designated by the Board of Directors.

Description of the Duties of the Treasurer

CCPA Board of Directors

The role of Treasurer includes:

- Collect income, pay expenses, and document details in a monthly report (10 times a year)
- Participate in Board Meetings
- Prepare the annual IRS 990 postcard report
- Submit budgets for the CPA annual report
- Mange Wells Fargo checking, savings, account, and Square account.

Description of the Duties of the Website Chair CCPA Board of Directors

Are you looking for a way to become involved with CCPA? If so, please consider becoming the new Website Chair. You do *not* need to be a tech wizard to be the Website Chair.
