

CPA's Board of Directors Responds to APA Independent Review

To our Members,

The CPA Board of Directors, like you, has spent the last few days reviewing the independent report provided to the APA Board of Directors by Mr. David Hoffman, a partner in the law firm of Sidley Austin in Chicago, IL. APA requested that Mr. Hoffman address the question of whether APA officials colluded with the Department of Defense, CIA, or other government officials "to support torture." Mr. Hoffman reports that APA fully cooperated with the investigation. The 500+ page report is extraordinarily detailed and thorough and is available in its entirety at www.apa.org. Our response is based on this profoundly important report.

We are appalled and disheartened at what the report reveals. The findings reveal not only an initial collusion between APA officials and those from the Department of Defense, but a continuing pattern of deceit that was aimed at misleading APA members and the public about this collusion. The report does not conclude that APA or anyone within it promoted torture. However, in its extensive effort to "curry favor" with the Department of Defense, APA lent support to the Department's interrogation program and thereby contributed to abuse by DoD and the CIA. It is disturbing and repellant to learn that our parent organization contributed to these abhorrent acts. The report describes a motivation to maintain intentionally "loose and porous" ethical constraints that allowed psychologist to participate in enhanced interrogations in the manner that DoD preferred, and to present a positive image to the public at the same time, during what was admittedly a very difficult and frightening time in our country. This was a violation of their responsibility and a betrayal of APA members and of our profession. These actions do not reflect who we are or our values as psychologists.

Our profession has a crucial role in society. CPA members and leaders share in the responsibility to ensure that our national organization safeguards the ethics of our field. We will watch, with you, to see how the APA Board of Directors moves forward with the recommendations included in their response to the report. Those of us who trusted the leaders of APA learn from this report that our trust was, in many cases, wholly misplaced. To the critics of APA, including CPA members, Chapters, and particularly our Monterey Bay Chapter that pushed tirelessly for accountability, we extend our humble thanks.

CPA will be submitting editorial comment to the news media to assure California consumers that psychology is a profession that values human dignity and human rights. CPA will also be communicating these same thoughts to APA in a letter that Actions of central figures within APA over the past decade have wounded all of us. It is now incumbent on APA to move forward in a manner that will restore the integrity not only of APA but of our profession.

Release of the Final Report of the Special Investigator From the APA Governance Affairs Office

Dear Members,

The APA Board of Directors commissioned Mr. David Hoffman of Sidley Austin to do a thorough and independent review related to allegations of a relationship the APA and Bush Administration related to the use of abusive interrogation techniques during the War on Terror. The report was recently received confidentially by Council who were in the process of providing recommendations to the Board when it was leaked to the New York Times. We had planned on a public release this coming week after Council's input, but we have now posted the complete report on the APA website along with a press release that includes the Board's initial recommendations. The supporting documents will be made available on our website this weekend.

The conclusions of the Independent Review report are deeply disturbing. Mr. Hoffman found evidence of an ongoing pattern of collusion between a small group of APA representatives and the Department of Defense. The Hoffman report states that the intent of the individuals who participated in the collusion was to "curry favor" with the Defense Department, and that may have enabled the government's use of abusive interrogation techniques. As a result, the 2005 PENS report became a document based at least as much on the desires of the DoD as on the needs of the psychology profession and the APA's commitment to human rights. Mr. Hoffman did not find evidence of collusion with the CIA or in the 2002 change to our Code of Ethics.

The Hoffman report clearly writes a difficult chapter in our organization's history. We sincerely apologize for the actions, policies and lack of independence from governmental influence detailed in the report. Our members, our organization, our profession, and the public expected and deserved better. We have announced a series of corrective actions related to policies and procedures to strengthen our organization and demonstrate our commitment to ethics and human rights. We realize it is a lengthy document, but encourage you to read the full report. Although the Executive Summary thoroughly overviews the findings, the specific details that provide the background (emails and interview data) are in the actual document. Reading the full document will help you to better understand how Mr. Hoffman came to his conclusions.

As troubling as the findings are, it is important that they have come to light so we can address them in a systematic and thoughtful way. As a result of the report, there will be significant changes in the organization, in terms of both policies and procedures. Dr. Stephen Behnke is no longer an employee of APA as a result of the findings in the Hoffman report, and other personnel actions are under consideration.

APA as an organization is a tremendous force for good in the world. Our members and our staff include so many talented, committed, and ethical psychologists. Our task now is to use what we have learned to ensure that something like this can never happen again, to return to a focus on our core values in everything we do, and to work to regain the trust of both our members and the public.

The months ahead will be very challenging for the association. We have much work ahead of us to address the findings of the report and to move toward healing. Nothing will <u>ever</u> undo what was done in the past, and we cannot deny that it is a stain on the honor of "Psychology," but we must and we will return to our roots to rebuild a new organization of which all of us can be proud. With your patience, support and engagement, we truly believe that we can come through this painful time an even stronger organization.

Action Alert – BOP Opens Comment Period on Final Changes in CE Regulations

Hello Everyone,

The Board of Psychology has issued the most recent 15-day notice for comment on the proposed Continuing Professional Development regulations. **The deadline for comment is July 22, 2015**.

In summary, at the most recent BOP meeting, they approved the regulations with a 27 CE credit limit (for "sponsored" or "traditional" CE). They also delayed the implementation date for one year (from January 1, 2016 to January 1, 2017). This delay is good since it will give us ample time to work with the BOP on clarifying many areas and will give us time to provide information to our members about the new regulations.

Please remember that comments should be directed <u>only</u> to the changes you see in the document (a few minor edits and the implementation delay). Those are the only comments the Board is required to consider. The number of credits allowable via traditional CE did not change with this version and so that is no longer open to comment according to the regulatory process the BOP is required to follow.

Colleague Awareness Resources and Education Chair

Principle A of our Ethics Code reminds us that, "Psychologists strive to be aware of the possible effect of their own physical and mental health on their ability to help those with whom they work." To address this complex issue, the California Psychological Association designed the CARE program "to provide education and access to referrals, and increase awareness of issues of diversity, compassion fatigue, secondary traumatization, prevention and early intervention." The CPA president appoints the state CARE Chairperson annually. The CCPA Board elects a county CARE Chair with the following responsibilities:

- 1. Attend monthly Board meetings;
- 2. Collaborate with other CARE Chairs in our region;
- 3. Participate in guarterly phone conferences called by the State CARE Chair;
- 4. Coordinate a biannual CE program for our members on a related topic such as vicarious trauma, compassion fatigue, and self-care principles.

I am completing my third year as CCPA's CARE Chair and it is time for me to move on. This position requires little time but is very satisfying. The Board meets monthly on Tuesdays from 11:30am to 12:45pm and provides a great forum for interacting with professionally active colleagues and becoming better informed of current professional issues. I especially encourage an early career psychologist to consider this position as a way to expand his/her network and to help the Board better address the needs of our younger members.
