

On October 8, two of our members, Drs. Betsy Braunstein and Lindsay Patton, gave an informative presentation for our most recent dinner meeting at the Lafayette Park hotel. Their topic was "PSYCHOLOGISTS' ROLE IN THE TREATMENT OF DIVORCING FAMILIES: THE ETHICS, ROLES AND CHALLENGES", and attendees learned about the ethical issues that impact the various ways psychologists work with families going through divorce.

As a local psychological association, CCPA is able to add our voices to the discussion of issues that impact psychologists throughout the state. One way this happens is through our LAN (Local Area Network) representative, Ellin Sadur. Recently she was on a conference call with other LAN representatives to CPA to review the current legislative season and began discussing priorities for next year. CPA recently shared information on the resolution of a potential class action lawsuit against Anthem Blue Cross (Wellpoint) regarding the way they determined "usual and customary rates" for reimbursement that had been ongoing for several years. Unfortunately, "the Judge ruled (and upheld on appeal) that he would not certify the "class", and this means that the lawsuit cannot proceed. CPA is offering 4 Trust 'Risk Management' webinars, and if you use the special code Trust-CA, CPA will get a portion of the registration fee. There is additional information about this on their websitewww.cpapsych.org. CPA also shared an update regarding BOP Licensing Committee and their work on clarifying the newly proposed CE regulations. This information is likely to be discussed by the full BOP in February 2016, but any potential date of implementation has been moved to January of 2019.

We are still interested in finding out about any members who are involved in any type of professional project that is helpful to local communities or community agencies.

Please think about joining the CCPA board. As Beth Ferree, our outgoing CARE chair noted, "It is a great forum for interacting with professionally active colleagues and becoming better informed of current professional issues". ## **CCPA Board Position:**

### Colleague Awareness Resources and Education Chair

Principle A of our Ethics Code reminds us that, "Psychologists strive to be aware of the possible effect of their own physical and mental health on their ability to help those with whom they work." To address this complex issue, the California Psychological Association designed the CARE program "to provide education and access to referrals, and increase awareness of issues of diversity, compassion fatigue, secondary traumatization, prevention and early intervention." The CPA president appoints the state CARE Chairperson annually. The CCPA Board elects a county CARE Chair with the following responsibilities:

- 1. Attend monthly Board meetings;
- 2. Collaborate with other CARE Chairs in our region;
- 3. Participate in quarterly phone conferences called by the State CARE Chair;
- 4. Coordinate a biannual CE program for our members on a related topic such as vicarious trauma, compassion fatigue, and self-care principles.

I am completing my third year as CCPA's CARE Chair and it is time for me to move on. This position requires little time but is very satisfying. The Board meets monthly on Tuesdays from 11:30am to 12:45pm and provides a great forum for interacting with professionally active colleagues and becoming better informed of current professional issues. I especially encourage an early career psychologist to consider this position as a way to expand his/her network and to help the Board better address the needs of our younger members.
